Current TCM certification for Mark Heard and Noel Chard was provided. Attendance of the TCM was recorded in the site attendance register.

C2 – Management system and operating procedures

The Operational Working Plan is present.

C4 - Storage, Handling, Labelling and Segregation

All materials were well segregated and controlled.

Other comments

Thank you for providing the required current TCM certification for Mark Heard and Noel Chard electronically. It was good to see new signage being rolled out and active management of traffic on site by staff.

There was good discussion on the local authority plans for HWRC in the borough and acknowledgement that annual limits at New Vale may be exceeded until another site is opened, this will be kept under review.

It's acknowledged that currently there is provision, funded by BGCBC, for out of hours security following previous incidents of attempted theft. This is in addition to the previously installed security measures, cameras/lighting/fencing etc.
