Tony Bruten attended site on Friday 9th September 2016.

The permitted area of the site had been cleared to a standard which now brings the site into compliance with the permit and so providing the site remains in this compliant state the consideration to revoke the permit has been revised and is no longer being considered at this time.

It was good to see the site operating within its permitted conditions as regarding the storage and acceptance of waste material.

I was disappointed to see that a third appointment to sit the Continuing Competency test for WAMITAB had been postponed and is now listed for 23rd September 2016. This means that the site still does not have a fully qualified TCM for the site. I have therefore had to breach you on the below permit conditions.

C1 Breach of permit condition 1.4.1 This condition states *Whenever the site is open to receive or dispatch waste, or is carrying out any of the specified waste management treatment or disposal operations, it shall be supervised by at least one member of staff who is suitably trained and fully conversant with the requirements of the licence and the working plan.*

You have failed to attend three previous appointments to sit the test and you have now provided a date of 23rd September 2016 for your test. You must ensure you attend that course.

I noted that there was also good progression in clearing waste from the exempt area of the site. This progress must be continued as discussed in order that compliance with the waste exemption to store waste is complied with.
