The CQA plan entitled "Infinis Energy Services Ltd. Pwllfawatkin Landfill Site Retro Drilling of Gas Wells Construction Quality Assurance Plan August 2018" was submitted in compliance with permit condition 2.7.4 which states "no construction of landfill infrastructure shall commence until the operator has submitted relevant construction proposals or a written request to use previous construction proposals and the agency has confirmed that it is satisfied with the construction proposal"

Having assessed the submission NRW acknowledge acceptance of the CQA plan with the following comments:

- Please ensure that the CV of the CQA inspector is forwarded to me with sufficient time for me to check the details prior to works commencing.

Following construction FCC are required to forward a CQA validation report as per condition 2.7.6 of the permit.

I would appreciate being kept informed of the build timeframe and actual construction dates to allow site inspection.

Please note the acceptance of this CQA plan by Natural Resources Wales does not mean that the assumptions, design, specification and testing will be suitable for any future development on site.
