4. Details of our assessment

This CAR form is in relation to an unannounced inspection carried out on the 22nd April 2022 as a result of reports of dust emissions coming from the site on the evening of the 19th April 2022.

Site Walkover:

Met with Shift Manager and carried out a site walkover which included the Reject building, Kiln area, Clinker dome and Crane bay stores - no dust emissions were noted during this site visit.

The roads were wet as a result of dust suppression measures and no issues were noticed from vehicle movement on site.

During the inspection it was noted that the large crane bay side doors were closed as required during a previous inspection and referenced in CAR_NRW0038997

Shift Manager log:

Review of shift manager log for the evening of the 19th April 2022 did not note anything unusual.

There were comments about cleaning required on site and a dusting from the eaves of the crane bay store however this was not significant.

CCTV Review:

A CCTV review was carried out from 6pm on the 19th April until 6am on the 20th April.

Footage from the Tower Camera which covers the entrance and exit roads, crane bay store, and clinker dome did not show any noticeable dust emissions during that time.

Footage from the Kiln Inlet did not show any noticeable dust emissions during that time.

No other issues noted on site.
