4. Details of our assessment

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dwr Cymru Cyfyngiedig's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Non compliance dated 24/12/2021: Dets Temp, Suspended Solids, Aluminium, Iron and

Chlorine for sample dated 02/08/2021 was submitted late on the 24/12/2021.

Our enforcement response is subject to further investigation.

Please note: This CAR is dated 31/12/2021 as this non-compliance relates to annual 2021 data, however for clarity, I carried out the compliance assessment on 22/04/2022.
