Late Data - UWWTD samples taken on 23/06/2021 and 26/06/2021 submitted 1 day late

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/2021 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on 26/04/2022.

## Important information
