We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

The non-compliances listed above were identified during our annual 2021 data audit. This audit assessed Dwr Cymru Cyfyngiedig's compliance at all of their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water

conditions (only applicable at some sewage treatment works).

Non-compliance dated 24/12/21: Condition 4.2.2 (S4.1) Late data. Dets Temp, BOD, Ammonia and Suspended Solids for sample dated 25/05/2021 was submitted late on the 24/12/2021.

Non-compliance dated 29/07/21: Condition 4.2.2 (S4.1) Late data. UWWTD sample taken on the 11/06/2021 was submitted one day late.

Our enforcement response is subject to further investigation.

Please note: This CAR is dated 31/12/2021 as these non-compliances relate to annual 2021 data, however for clarity, I carried out the compliance assessment on 22/04/2022.
