4. Details of our assessment

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/01/2021 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on the 27/04/2022.

The non-compliance relates to incorrect information being submitted on the Annual

Summary Report in that the sampling frequency should have been increased to 12 samples following a sample failure.

Under Regulation 38 (2) of the Environmental Permitting Regulations 2016, it is an offence for a person to fail to comply with or to contravene an environmental permit condition.

Our enforcement response is subject to further investigation.
