Routine Inspection - Handover 1st Inspection to site with Kathryn Sampson - Site Manager.

Inspections main focus was of general awareness, familiarisation and introduction as new site inspector.

- We discussed the transfer station fire on the 5th July 2016 and potential sources. It was unclear how the fire started but was quickly extinguished by the fire service with no damage to the building.
- We discussed the need to report such events to Natural Resources Wales immediately on 0800 807060 as per Permit requirements and we also agreed to complete a Schedule 5 Notification although not currently a requirement under the current Waste Management Licence, Biffa agreed to do this - NRW have subsequently received this notification.
- We discussed the current WML and the need to have an updated EPR Permit with modern conditions. NRW to get clarification on Permit status and provide an update to Biffa. NRW have subsequently provided an update and we will continue with this dialogue

The plan moving forward is to undertake routine site inspections and audits over the next 12 months with the main focus being:

- Permit - Updated to Modern EPR Conditions
- Housekeeping - General litter and debris around site
- Fire Risk Assessment - A general review of this document
- Waste Storage and tonnage limits - Audit this to ensure all waste quantities are within Permit limits.

No permit breaches (non-compliances are being issued with this CAR Form).
