Site meeting discussing FPMP (Fire Prevention and Mitigation Plan) with Biffa Waste Services (Owen Thirkettle, Graham Peacock and Hannah Clifford), Matthew Bradford SWFRS.

NRW have reviewed the above document SLR Ref 402.00034.00553/FPP dated February 2017. The following Comments were made:

- There is no clear distance given along the perimeter fence adjacent to Valero. There should be a minimum of 6 metres and this will be a variable with the new guidance 2017 depending on waste type.
- Is the fire detection system linked to a remote control centre rather than directly through to the fire service (FRS) (Are all staff aware of what the process in place is for notifying the FRS via the detection system)
- Again, what training is giving to staff for fire-fighting purposes, a number of fire-fighting jets (hose reels) are on site but the waste is located inside the building and there seems a lot of emphasis on staff tackling a fire.
- It would be ideal for the FPMP to have a list of sensitive receptors (Business, schools, etc.) that can be contacted if necessary during an incident.
- Vehicles catching fire in the building has not been included
- Drainage plans outside the premises.

It was noted that there has been significant improvements on site over the last 12 months. In order to comply with the new requirements in the FPMP we need to ensure that these improvements are maintained. We discussed in detail the back of the site and the boundary fence with Valero and was agreed that a meeting between yourself and Valero will take place ASAP.

Furthermore, your FPMP should include details on the Primary Authority Scheme you have in place with Hampshire FRS.
