Environment Officer Alice Sims conducted a site inspection alongside an exports inspection at the Biffa site, Viking Road.

She met with Site Supervisor Andrew Bickle who provided a guided tour of the site which contributed towards the exports and operation checklist that Alice was required to complete.

During the tour of the site, the areas for each waste stream and the processing operations were observed. There are various plastics and paper wastes that are stored and processed on-site, both of which are baled. Neither waste streams are stored for longer than a week due to weekly pick ups and lack of storage capacity. Approximately 80 tonnes of paper is removed and 40 tonnes of plastic weekly.

There had been some recent contributions towards on-site fire precautions including a new wall constructed at the rear of the site and plans to construct walls inside the main building to reinforce separation between waste streams.

China Exports Information

The only waste stream currently exported to China from the site is cardboard. Other countries that they export waste to are France, Holland, Germany and Switzerland, where they send paper and LDPE film. The agreed contamination limit for waste exports is 10%. Papers are also sold to UK buyers, such as Coltar Recycling.

Andrew informed Alice that the site was fully aware of the restrictions China intended to impose on certain waste stream imports and stated that they have experienced relating issues such as containers of waste failing to turn up. To tackle these issues, the site has used different companies for exportation to broaden their options. These are arranged by in-house brokers within Biffa's sales team.

The main impacts upon the site's business since the Chinese import restrictions is the fall in product prices and finding new places to export waste to.

Summary

Overall the site was tidy and organised with no notable points of concern. During the tour there was an emphasis on the safety procedures when accompanying a guest around the site. Andrew supplied all relevant information clearly.
