Breaches

C4 - Management - Storage, Handling, Labelling & Segregation;

Breach of condition 2.1.1: Schedule 1, table 1.1

"All wastes unless otherwise specified shall be stored and treated inside a building upon an impermeable surface with sealed drainage."

Non-specified waste stored outside the building (see "Schedule 6 - Interpretation" of permit for definition of building), as building was severely damaged. Following the fire, waste continued to be accepted and stored on a site not suitable for purpose and storing material prone to flare-ups.

Category 2 breach - score suspended

A regulation 36 enforcement notice requiring compliance with permit condition 2.1.1 was served, with a compliance deadline of 4th April 2016.

The waste onsite appeared to remain unchanged, though an area of the wrapping had come away exposing the waste. To reduce pollution risks and attraction of pests, please cover the waste as best as possible.
