Site inspection of waste storage onsite. Weather was wet with heavy showers during visit.

Breaches

C2) Management - Management Systems & Operating Procedures: Breach of condition 1.1.1

"The operator shall manage and operate the activities:

(a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closures and those drawn to the attention of the operator as a result of complaints;" - The procedures detailed in Siteserv Recycling Environment Management System are not being applied, waste is being stored outside the building. NRW also was not notified of this activity.

Category 3 breach

C4) Management - Storage, Handling, Labelling & Segregation: Breach of condition 2.1.1; Schedule 1, table 1.1

"All wastes unless otherwise specified shall be stored and treated inside a building upon an impermeable surface with sealed drainage."

Non-specified waste stored outside the building (see "Schedule 6 - Interpretation" of permit for definition of building)

Category 3 breach

Mixed general waste was being stored outside of the building during the inspection. The Energy from Waste incinerator has not been accepting waste and this has caused significant build-up of waste onsite. As such there is more waste onsite than can be safely contained within the building. Mixed waste was also stored in the side of the building damaged by the fire. This part of the building does not meet the criteria of "building" set out in your permit, as it does not completely minimise emissions. The location may be more suitable than an uncovered pile in the yard, as it does provide some cover, reducing the access of pests and water ingress.

The main building was not inspected in this inspection.

The rear yard was also being used to store waste, including rubble, plasterboard, scrap metal, p.v.c window frames, and the residual fines from the waste fire - still covered with silage wrap and tyres to prevent water ingress.

Siteserv have now diverted incoming wastes to the hangars at Triple Crown house, to allow them to concentrate on removing the waste from the transfer station on Llandow Industrial Estate. An estimated date for removing the waste was given as 30th September.
