Breaches

C4 - Management - Storage, Handling, Labelling & Segregation; Site is in breach of condition 2.1.1; schedule 1 - table S1.1;

"All wastes unless otherwise specified shall be stored and treated inside a building upon an impermeable surface with sealed drainage."

CCS Score Cat 3

A waste backlog has built up at the waste transfer station, originally a result of closures over the Christmas period, and is being stored outside of the building. The original deadline and extended deadline set by Siteserv Recycling to clear this waste and bring the site back into compliance was not met. This is due to the receiving incinerator site having unpredicted closures, and the site identified in the contingency plan not being able to provide sufficient credit to allow the waste to be cleared as soon. As a result waste is still stored outside of the main building.

Siteserv Recycling estimate it could take up to 5 weeks to clear the waste relying on their contingency site alone. However waste will be cleared much sooner if their primary receiver site is open to taking waste again.

Siteserv Recycling have taken steps to mitigate the impacts of storing this waste outside, by covering the waste in polyethylene sheeting, and weighting this down. This has reduced the risk of any potential polluting run-off from the waste and reduced the risk of windblown litter. A category 3 breach has been scored for this non-compliance, because the covering does not meet the criteria of a building - it is liable to tear, exposing gaps, and has to be exposed to allow the waste to be accessed to be removed.

Another inspection has been scheduled in for 3 weeks time. Siteserv Recycling requested that Dai Walters, Environment Management Team Leader also attend the next meeting and inspection.
