Site inspection with NRW officer Will Powell, Tony Morris (Site Serv), Barry Mitchell (administrator) and Martin England. Weather was dry throughout.

C4 - Management - Storage, Handling, Labelling & Segregation; Site is in breach of condition 2.1.1; schedule 1 – table s1.1:


**“All waste unless otherwise specified shall be stored and treated inside a building upon an impermeable surface with sealed drainage.”**

In that fire damaged waste is being stored in the external yard area rather than inside a building; fire damaged waste is not a specified waste. Score is suspended as an EPR Regulation 36 enforcement notice has been served requiring compliance with the permit condition.

### **CCS score Cat 3 - Suspended Score**

Inspected the main yard. The volume of the light weight fire-damaged waste has reduced since the last visit. Site Serv estimate around 1000 tonnes are still onsite, which seems a reasonable estimation. Whilst the waste has reduced in volume since the previous visit, Site Serv are disappointed with progress over the last week. A delay has occurred at the receiving site, Viridor, meaning only a few loads have left site over the week. Viridor have now resumed receiving loads from Site Serv.

Inside the building the waste volumes are okay. No strong odour was detected offsite. Waste barrels, with glue residues were being stored on site. These wastes may be hazardous. If this is the case, a consignment note will need to be produced for the movement of the waste, and the waste should be handled with care.
