Site inspection with NRW officers Alex Bowder and Will Powell, and Siteserv Recycling representatives Nigel England, and Carl Jones. Weather was warm and dry during visit.

Breaches

C4 – Management - Storage, Handling, Labelling and segregation;

Breach of condition 2.1.1, table :

“All wastes unless otherwise specified shall be stored and treated inside a building upon an impermeable surface with sealed drainage”

Non-specified waste stored outside the building (see “Schedule 6 – Interpretation” of permit for definition of building) as building was several damaged and removed.

Category 3 breach

Actions since last inspection

Some of the mixed general waste around the back entrance has been removed. The pile has been split into two. The rest of the waste remains onsite.

Site inspection

A quick site inspection to look at progress made onsite. The pile of waste by the site entrance had been split in two, and the waste up against the push wall was due to go out that week. The rest of the waste from this pile had been pushed up against the end of the covered pile of mixed general waste. The waste material in this pile looked smaller/more fragmented than the other wastes.

Some Siteserv bin bags looked new onsite – however this was from a litter pick. There was a lot of very fine, light weight material that looked to have blown off site. Siteserv will ensure the area outside the boundary is swept.

Nigel England anticipates that all the waste will be cleared by end of July.
