“All wastes unless otherwise specified shall be stored and treated inside a building upon an impermeable surface with sealed drainage”

Non-specified waste stored outside the building (see “Schedule 6 – Interpretation” of permit for definition of building) as building was several damaged and removed.

Actions since last visit

Some of the fire damaged waste has been removed.

Site visit

The site was open but no one was present during visit. Several loads of the fire damaged waste has been removed and taken to Siteserv Recycling's other site. Siteserv Recycling hope to have this site cleared by Christmas.
