Environment officers Laoni Tye and Craig Coleman attended site on the 29th March 2018 as an unannounced visit. The site was non-operational and was closed so we were unable to physically go on to site although we viewed it from outside of the site boundary. The gates were locked and secured. There was a breach recorded which is outlined below.

C4 – Management - Storage, Handling, Labelling and segregation. Category 3 breach.

Condition 2.1.1 Table S1.1 which states that all wastes unless otherwise specified shall be stored and treated inside a building upon an impermeable surface with sealed drainage.

There is fire damaged waste left over from the previous fire stored outside of the building which is not in line with the requirements of the permit. The volume provided by the site has estimated approximately 400 tonnes left on site. There is a compliance notice in force for its removal from site.

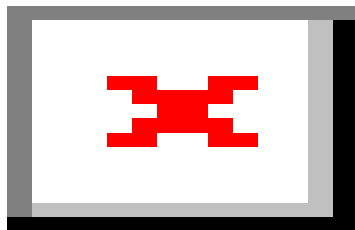
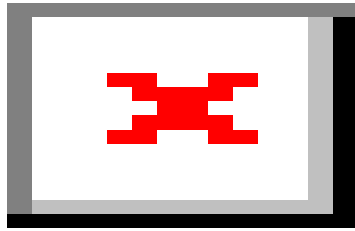
Please note that due to the fact the notice was issued more than 6 months ago this score will no longer remain suspended which is in line with our Compliance Classification Scheme (CCS) guidance. All other scores prior to this will remain suspended, providing the compliance notice is complied with by the deadline of 31st August 2018.
