### Breaches

C4 – Management - Storage, Handling, Labelling and segregation;

Breach of condition 2.1.1, table :

“All wastes unless otherwise specified shall be stored and treated inside a building upon an impermeable surface with sealed drainage”

Non-specified waste stored outside the building (see “Schedule 6 – Interpretation” of permit for definition of building) as building was several damaged and removed.

### Category 3 breach

### Actions since previous visit

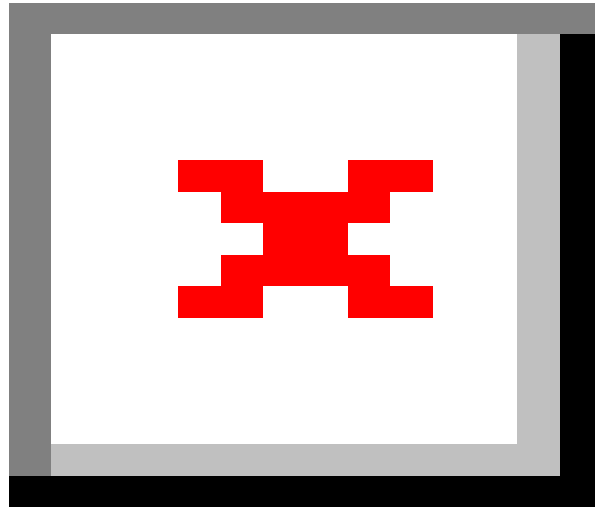
Much of the waste has been removed from site, only one pile of mixed waste and one pile of fines remain.

### Site Visit

Unable to access site as the gates were locked. The site has been largely cleared, with two piles remaining. Only the one pile of waste, originally brought over from Triple Crown House in September 2015 after the fire. The waste is covered, but there are gaps in the cover. This waste needs to be removed. The pile of waste fines produced from the processing of waste from the 1<sup>st</sup> fire also remain onsite. These need removing as well.

### Site handover

There will be a change of regulator this month for Siteserv Recycling Ltd. A handover meeting will be arranged for later in February, which should hopefully coincide with the appointment of Siteserv's new SHEQ.
