There is an annual subsistence charge for your permit unless your permit is only for mobile plant, where instead we will charge for each deployment.

The annual charge is due on demand in the year that we issue the permit and then on 1 April each year. However due to updates to our billing systems, the initial charge will not be invoiced until February 2016.
