The site continues to breach conditions and has a particular problem with excess waste which is not being stored correctly. I have breached the site on the following conditions

A1 Specified waste operations. Breach of condition 2.1.1. Waste in excess of permitted weight stored on site.

Resolution. Waste must be reduced to within permitted weights.

B4. Containment of stored materials. Breach of condition 3.1.1. Waste not being stored correctly in that it is spilling off impermeable surface with sealed drainage.

Resolution. Amount of waste to be reduced and correctly stored on identified impermeable surface with sealed drainage.

C4. Storage, handling and segregation. Breach of conditions 6.5.1 & 2. Waste litter blowing of falling outside boundary and failure to retrieve litter within specified time.

Breach of 5.6.1. possible odour causing waste being stored longer than 48 hours

Resolution. Ensure that all waste is securely stored within the permitted area and that all possible odour causing waste is removed from site within specified timescale.
