A1. Breach of condition 2.1.1. Waste in excess of permitted weight stored on site. Since my last CAR form on 28/05/2015 I have been visiting the site on regular occasions and the amount of waste has steadily increased even following assurances from Adrian Lewis that the waste stored will be reduced to permitted levels. I estimate that the amount of waste stored on site is almost double that which was on the site at the beginning of 2015.

Resolution. The waste must be reduced to permitted weights, work to reduce the waste must start forthwith and I would expect that even given current financial issues that at least 100 tonnes should be removed each week.

B4. Breach of conditions 3.1.1 & 3.1.4. Waste spilling off impemeable surface and onto hardstanding ground which does not have correct connection to sealed drainage. Liquids that are running off impermeable surface are not being collected by sealed drainage.

Resolution. Reduce waste in order that it is all stored on impermeable surface. This should be commenced forthwith at a minimum rate suggested above.

C4. Breach of condition 5.6.1. Odorous causing waste stored longer than 48 hours and not in sealed conatiners and waste likely to attract pests also being stored longer that the permitted 48 hours.

F3. Breach of condition 6.5.1. Waste amterial being blown or falling over the site boundary onto adjoining land.

Resolution. Waste to be securely stored on site and boundary fence to be maintained to prevent waste leaving site. This is to be done immediately.
