WARNING

On 31st March 2022 a routine sample was taken. The sample was discoloured, almost

black.

Analysis detected 60.5mg/L of suspended solids.

This is a breach of permit condition 6. Composition - suspended solid limit 50mg/L.

Please investigate the cause of the breach and take measures to prevent a recurrence. The deadline for gaining compliance and submitting information is 26th May 2022.
