We need more information about your application.

Thank you for your application received on 27/04/2017. I need to ask you for some more information before I can confirm that your application is duly made. The information required is summarised below:

SRF/RDF Processing

From the operating description provided in your application it is not clear that the proposed SRF/RDF activity would amount to an Installation listed activity. If you wish to continue to apply for a variation to an permit in the current manner, please can you submit evidence to support your position.

The document 'Regulatory Guidance Note 2: Understanding the meaning of regulated facility' has been used in this assessment, and is available at <https://www.gov.uk/government/publications/rgn-2-understanding-the-meaning-of-regulated-facility>. Please see the extract of Appendix 1 (S3 P2 Ch 5) which describes waste pre-treatment activities which would need to occur at a facility for it to be considered a listed activity;

Note 5.4.5: Where a waste treatment directly and intentionally improves the quality of the waste as a fuel by changing the composition of the waste in a way that changes one or more of the following 5 parameters:

- a) Calorific (or heating) value;*
- b) Moisture content;*
- c) Ash content;*
- d) Chemical composition;*
- e) Heavy metal content*

The operation described within your application do not presently satisfy these requirements.

Waste Water Treatment Plant

I need to ask you for some more information regarding your proposed Waste Water Treatment Plant. Please would you confirm the capacity of the processing equipment, measured in tonnes (not including the quality control and storage sections of the settlement ditch). This will be used to clarify if this activity would constitute an Installation listed activity in itself.

Air Quality Modelling electronic files

Once the above has been determined, we will request that digital copies of the ADMS modelling data included in your application report be submitted, to allow our modelling teams to further assess your air quality analysis.

OPRA Charging File

Unfortunately you've submitted an OPRA form which doesn't align to our current charging scheme. The OPRA file that has been submitted appears to be a legacy document and we will need you to complete and return a NRW OPRA form, valid for this year. The correct OPRA form for Waste sites (i.e. your current application) is available on our website at <https://naturalresources.wales/about-us/what-we-do/how-we-regulate-you/our-charges/?lang=en>. Using this, we will be able to confirm if the correct fee has been paid, or any changes that may be required.

Please reply within 10 working days from the date of this letter. If we don't hear from you, we must return your application and fee.

When we receive the missing items we'll continue to check the details in your application. If there's enough there for us to begin the process of deciding whether or not we can grant your application we say the application is 'duly made' and we'll let you know this by letter.
