We looked through a sample of returns to check that they were completed correctly. All records appeared to be in good order. We queried whether or not Aberdare Demolition could be registered as the premises code or producer instead of each individual premises, however we now understand that individual premises do need to be registered and therefore please continue completing the forms as you are.

The site itself is still currently non operational and is only being used for storing skips, as explained by Alison. All waste is taken directly from the site it is produced to the relevant authorised facility, it is not stored anywhere in the interim.
