Site inspection with Siteserv Recycling directors Nigel England, Luke England, and NRW team leader Rhys Hughes and Environment Officer Will Powell. Weather was dry throughout visit, but had been raining earlier that day.

Breaches

No breaches were scored during this visit.

Hangar A

Hangar A was being used to store single stream wastes; paper and card. Some plant and machinery was being installed to allow baling of wastes and a picking line was also in place. The volumes of waste were relatively low, with piles of wastes stored apart.

A generator has been installed at the rear of Hangar A between the hangar and the adjacent caravan park. The generator will provide power to the waste processing machinery. Some noise abatement insulation has been put around parts of the generator to reduce it's noise impact.

Hangar B

Hangar B is still being used to store large volumes of hard plastic. Siteserv Recycling have found an outlet for some of their hard plastic, particularly clean, source segregated plastics. These are being granulated down for a plastics recycling company.

Other wastes include plastics, glass sheets and windows, and plasterboard. Siteserv have been removing wastes these wastes from the general waste, stored near the shutter doors. Waste was stored in a small pile, no higher than the shutter door. No odours were detected from the waste, or signs of heating.

Outside

Siteserv have removed the fines previously stored in Hangar B, and stored these on hardstanding outside under polyethylene wrap. Inspection of this material found no signs of leachate or any other run-off coming from the fines. Please could you let us know your intentions for this material, as it's current storage is not suitable for long-term storage.
