4. Details of our assessment

The non-compliances listed above were identified during our annual 2021 data audit. This audit assessed Dwr Cymru Cyfyngiedig's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Non-compliance dated 24/12/2021: OSM 9 no flow sample dated 23/06/2021 was submitted late on the 24/12/2021.

Non-compliance dated 31/12/2021: OSM 9 no flow sample dated 20/05/2021 was submitted late on the 28/02/2022.

Our enforcement response is subject to further investigation.

Please note: This CAR is dated 31/12/2021 as these non-compliances relate to annual 2021 data, however for clarity, I carried out the compliance assessment on 22/04/2022.
