3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

4 non-compliances:

1. Late data. UWWTD samples taken on 09/06/2021 & 29/06/2021 submitted 1 day late.
2. Late notification. Late notification of sample reschedule, original sample date 18/11/2021, notification received on 13/12/2021 (>21 days after sample schedule date).
3. UV - Missing data. UV transmissivity data missing for the following records: 04/10/2021 15:30, 29/12/2021 05:15, 14/10/2021 09:00, 10/10/2021 07:00.
4. UV - Efficacy data. 17 of the 18 complete samples provided (16 required) don't have an applied dose recorded at the time of sampling to coincide with other dets. 1 of the 18 samples doesn't have a flow reading recorded at the time of sampling to coincide with other dets.

The non-compliances listed above were identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/21 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on 23/4/2022.

Our enforcement response is subject to further investigation.
