4. Details of our assessment

Following a site inspection on the 9th March the Operator was requested to investigate leakage from the bunded chemical store on Yard C and report back (Reference CAR_NRW0039544 Action 3).

The Operator reported back on the 18/03/22 confirming that the container base showed signs of corrosion potentially caused by minor spills during dispensing operations. There have been some minor leaks from the containment unit onto the underlying yard.

NRW is of the opinion that this is a breach of Condition 3.2.3 (B4 - Containment of stored materials - C3). Corrosion meant that there was not adequate secondary containment of liquid chemicals resulting in the potential for minor pollution to surface waters.

As a temporary measure the Operator has put plastic drip trays inside the container to catch any further spills. They have stated that the hygiene team are reportedly checking this storage area daily and have been instructed to report any issues.

On the 04/04/22 the Operator provided a full investigation report (ICAR) into the leakage from this bunded chemical store with a number of actions to be completed. These are generally considered appropriate. We would also advise the Operator, as a form of best practice, to raise awareness across the organisation regarding the importance of procuring chemical storage and secondary containment appropriate to the nature of chemicals stored, i.e. resistance to corrosion for chemicals such as Maxichlor which are corrosive and harmful to the environment. The Operator should check other such storage installations across the organisation.
