## 4. Details of our assessment

This was a routine, unannounced site inspection. Officers were met by the new Site Manager who accompanied them around site.

There was no activity at the Materials Recycling Facility (MRF) and there was no waste stored inside the building.

Outside of the MRF there was a metal storage container which contained fly ash and incinerator bottom ash (IBA) from the Small Waste Incineration Plant (SWIP)(discussed in CAR\_NRW0039582 and NRW0039627). Following the site inspection, the operator confirmed that this waste will be consigned as hazardous waste and taken to a site authorised to accept it.

Action 1: Provide NRW with completed consignment notes for the mixed fly ash/ incinerator bottom ash waste.
