3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

This was a routine, unannounced site inspection. Officers were accompanied by the new Site Manger.

Gas engine 1 was running but gas engine 2 was not operational. The Site Manger explained that maintenance had been carried out on engine 2 since the last site inspection (03.03.22) but other issues had occurred, resulting in the engine not being operational.

The operator has provided NRW with copies of the service reports for maintenance completed on gas engine 2 02.03.22 and 14.04.22.

Within the gas engine compound, officers observed two drums of antifreeze coolant and Intermediate Bulk Containers (IBCs) containing gas engine oil. These were all stored without secondary containment and there was some staining on the floor near the IBCs. NRW considers this a breach of permit condition 3.2.3 (B4-CCS3) which states

'All liquids in containers, whose emission to water or land could cause pollution, shall be provided with secondary containment, unless the operator has used other appropriate measures to prevent or where that is not practicable, to minimise, leakage and spillage from the primary container.'

Action 1: Ensure drums/ IBCs containing potentially polluting substances stored within the gas compound are provided with adequate secondary containment e.g. bunding, drip trays. Provide photographs to NRW by the specified date to show this has been completed.
