4. Details of our assessment

Late data. No flow sample dated 23/04/2021 submitted on 24/12/2021.

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 24/12/2021 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on 23/4/2022.

Our enforcement response is subject to further investigation.
