4. Details of our assessment

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this Compliance Assessment Report (CAR) is dated the 31 December 2021 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on the 29 April 2022.

Our enforcement response is subject to further investigation.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
