WQ-D2 Reporting: OSM 9 -

During our annual 2021 data audit it was identified that OSM results for detrs Temp, BOD, Ammonia & Suspended Solids for sample dated 09/06/2021 was submitted on 24/12/2021.

WQ-C1 Emissions to water: Condition 18(d)(II) -

1 sample missing result for Faecal Coliforms.

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/21 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on 26/04/2022. Our enforcement response is subject to further investigation.
