4. Details of our assessment

WQ-D2 Reporting - Condition 4.2.2 (S4.1) -

During our annual 2021 data audit it was identified that a no flow sample dated the 14/07/2021 was submitted on the 24/12/2021.

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/21 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on 26/04/2022. Our enforcement response is subject to further investigation.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
