4. Details of our assessment

Improvement Condition 10 in V002 of TRW's EPR Permit stated that emissions to air should be monitored and then, based on these initial results, TRW should propose a monitoring plan for the future. The frequency agreed between TRW and Natural Resources Wales (NRW) was every three years.

The monitoring report was received on 28th April 2022, it was due in May 2021. ZF have been issued with a Cat 4 non-compliance for late reporting. Please ensure that future reports are sent to NRW by the due date.

The next report is due in May 2025.

Emissions were measured on 1st March 2022 at emission points A8/1 and A9. Hydrogen chloride emissions from emission point A8/1 were measured as 0.02mg/m³ and hydrogen fluoride emissions from the same emission point were measured as 1.94mg/m³. Sulphuric acid mist emissions from emission point A9 were measured as 0.14mg/m³. The uncertainty for all measurements was 13%. These concentrations are considerably lower than the lowest values quoted in the Bref document for the surface treatment of metals.
