## 3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

## 4. Details of our assessment

The non-compliances listed above were identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Missing four results for BOD, Ammonia & TSS, resulted in a category 3 non-compliance for a sampling shortfall, against permit condition 3.3.1. The non-compliance was recorded as a category 3 because an elevated concentration of any of the above parameters, has the

potential to impact the receiving watercourse with minor effect. Through missing the four results, it is not possible to confirm if the above parameters were within compliant limits with the permit or not, during the usual reporting period.

The second non-compliance is for failing to report the above sampling shortfall in the ASR, and is therefore not compliant with permit condition 4.2.2. By failing to report the missing sample results, officers would have been unable to fully assess any potential environmental impact caused by the missing results, therefore, resulting in a category 3 non-compliance.

Please note: this CAR is dated 31/12/21 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on 29/04/2022.

Our enforcement response is subject to further investigation.
