(only applicable at some sewage treatment works) and Urban Waste Water conditions
(only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/21 as these non-compliances relate to annual 2021 data, however for clarity I carried out the compliance assessment on 28/04/2022.
