Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

A non-compliance against permit condition 4.2.2 has been recorded, for a late submission UWWTD sample data. The data was submitted one day late and therefore, resulted in a category 4 non-compliance only.

Please note: this CAR is dated 31/12/21 as this non-compliance relates to annual 2021 data, however for clarity I carried out the compliance assessment on 29/04/2022.

Our enforcement response is subject to further investigation.
