## 4. Details of our assessment

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

The late submission of no flows data dated 19/07/2021, received 24/12/2021, resulted in a category 4 non-compliance of permit condition OSM 9. This is because the data was received five months after the no flows was recorded. However, the risk posed from a no flow record from this asset is low because the normal discharge rate is low and the receiving watercourse is small, and at this time of year no to low flows are not uncommon because the catchment is small.

Please note: this CAR is dated 31/12/21 as this non-compliance relates to annual 2021 data, however for clarity I carried out the compliance assessment on 29/04/2022.

Our enforcement response is subject to further investigation.
