## 4. Details of our assessment

The non-compliance listed above was identified during our annual 2021 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

The late submission of pH results (received on 24/12/2021) over the following sample dates: 05/01/2021, 10/02/2021, 09/03/2021, 27/04/2021, 10/05/2021, 09/06/2021 and 26/07/2021, was not compliant with OSM permit condition 9. This resulted in a category 3 non-compliance, due to the volume of late data received and because officers would have been unable to fully investigate any potential non-compliances within the data effectively, and resolve any potential issues on the site because the data was submitted late. Investigating issues with pH is important because lowered or raised pH has the potential to impact the environment/receiving watercourse.

Please note: this CAR is dated 31/12/21 as this non-compliance relates to annual 2021 data, however for clarity I carried out the compliance assessment on 29/04/2022.

Our enforcement response is subject to further investigation.

## Important information
