Senior Environment Officer Eleanor Davies and Environment Officer Alex Bowder attended site following notification from Atlantic Recycling Ltd that all of the waste had been removed from the Field 1 area of site.

We met with Phil Ridley and John Edwards. It was confirmed that there was no waste present on Field 1 at the time of inspection. As such the suspension of the acceptance of all wastes onto field 1 has been withdrawn - please see attached Withdrawal of suspension notice.

While the waste has been removed from site, this was not carried out in line with the dates specified in the Regulation 37 suspension notice and associated deadline extensions. As such we will now consider what enforcement action is appropriate in line with our Enforcement and Prosecution Policy.
