Site was attended by Environment Officer Damien Downes and Anthony Bruten of Natural Resources Wales. Representation of Atlantic Recycling by David Neal, John Edwards and Phil Ridley. The weather was sunny and dry.

The inspection being carried out to assess compliance with the Regulation 36 and Regulation 37 served on Atlantic Recycling Limited on 6th June 2016.

Regulation 36 Notice

The Regulation 36 notice required that the tarmac area within the transfer station be improved so that it complies with the requirements of the permit condition 2.1.1 in that all hazardous and non-hazardous wastes shall be on an impermeable surface with sealed drainage.

During the inspection on 12th April 2017 it was evident that tarmac area had not been replaced and is being used to store waste materials.

Regulation 37 Notice

In Schedule 2 of the Regulation 37, 'Steps to be taken' stated; remove all waste that has been stored on site in the field 1 area of the site for a period longer than 6 months.

On the 26th September 2016, NRW recorded the following observations; there remains approximately between 7-9,000T of baled waste that has been on site for, in the case of approximately half of the waste, since 2012/13. The other half is approximately 1 year old.

Approximately 16,000T of shredded waste has been removed from field 1.

It was evident during the inspection on the 12th April 2017 that a significant volume of legacy waste material remained on the field 1 area.

In light of the above and observations made during the site inspection, Natural Resources Wales considers that the Regulation 36 and Regulation 37 notices have not been complied with. We will now consider what enforcement action is appropriate and notify you.
