This Compliance Assessment Report (CAR) form has been completed following the review of the CQA Validation report submission received on the 25 October 2018 for the installation of gas well infrastructure at the Pwllfawatkin Landfill site permit EPR/BU8819IV

The CQA plan entitled "**Infinis Energy Services Ltd.** Pwllfawatkin Landfill Site Retro Drilling of Gas Wells Construction Quality Assurance Report October 2018" was submitted in compliance with permit condition 2.7.6

Having assessed the submission NRW acknowledge acceptance of the CQA validation/assurance report.

Comment: The report records an issue (page 9) encountered where butt fusion weld tickets for 3 joints "were not available from the welding equipment as they had been prepared in advance of the CQA inspector's arrival. Each joint was visually inspected by the CQA inspector prior to its incorporation within the works"

The CQA visual inspection should be fine (as an air leak should be picked up quickly if it failed and they will be easy to isolate and replace if there was indeed an issue).

The annual leak detection survey will also ensure any pipework/weld issues are picked up.

Please note the acceptance of this CQA Validation Report by Natural Resources Wales does not mean that the assumptions, design, specification and testing will be suitable for any future development on site.
