Compliance Assessment:

Schedule 6 part A notification was received, in compliance with conditions 4.3.1 and 4.3.2, via email on 9/8/18 The notification was an amended S6 detailing tributyltin limit breaches.

The ammonical nitrogen breaches have previously been assessed and scored under CAR form CAR_NRW0033659

The tributyltin sample date and monitoring results are detailed below:

07/06/2018, BH17A - 0.00004mg/l

19/07/2018, BH17A <40ng/l

The permit limit is 0.02Ug/l the above units equate to 0.04ug/l and therefore, as notified by the operator, is a limit breach.

Amendment: following additional information received via email dated 12/11/18 there is no breach of permit limit. The previously marked breach has been deleted and the CCS score removed.

~~A breach of condition 3.6.1, table S4.4 for tributyltin at BH17A has been recorded. As the original breach occurred in June, and the resampling in July, the score will be consolidated as 1 CCS Cat 3 in Q2. (ends 30 June 2018)~~
