Tony Bruten attended site and met with George Harvey.

We discussed that no new export shipments had occurred since 2016 and that SWWR had not brought any new waste to site since my previous visit.

No processing was being carried out at site and all existing processed chipped wood was now being removed by road.

SWWR are currently in negotiations with ABP the land owners as to future permitted operations at site.

The stockpiles remain as during my previous inspection with the necessary fire breaks between stockpiles.

I informed SWWR that at this time there are no breaches of the sections of the permit inspected, however if there is no movement of stockpiles then I would be discussing rotation of waste stored on site at my next inspection.

Whilst at site we did discuss Waste Wood stored at the Coalyard site and this will be covered in a separate document as it is not a permitted location.
