D Downes and L Moggridge on site in company with George Harvey - South Wales Wood Recycling. Weather dry. Purpose of visit; site inspection and to serve Regulation 36 Notice (EPR 2010) comply with permit condition 1.1.1;

Reduce the amount of recovered chipped wood wastes onsite to bring it within the maximum storage capacity of 7,500. As specified in the document South Wales Wood Recycling Ltd, **EMS - Process Description, Management, and Controls.**

All of the recovered chipped wood wastes to be stored in stockpiles no greater than half the maximum storage capacity of 3,750 tonnes.

C 3 - Materials Acceptance - CAT 2 - Permit Condition 1.1.1 - it is estimated that in excess of 20,000 tonnes of recovered waste wood chip is stored on site in one single waste mass without the benefit of any fire breaks. In the South Wales Wood Recycling Ltd Fire Risk Assessment (APRIL 2015) it states within the Storage Methods;

(1) stockpile heights will not exceed 7 metres - it is clear that this is not the case - estimate stack height in excess of 10 metres.

(2) no stockpile should exceed half of the maximum storage capacity - 3,750 tonnes. It is evident that there is in excess of 8,000 tonnes of processed wood chip stored in one single waste mass.

WOOD CHIP FIRE

During the inspection we were taken to the rear section of the stockpile was partially on fire and smouldering. Continue to control and eliminate the fire affected area.
