WASTE TRANSFER STATION, CAERWENT ARMY TRAINING ESTATE, CAERWENT ENVIRONMENTAL PERMITTING REGULATIONS 2010

I write in connection with the above operation, NRW reference: 01603972 at the Caerwent Army Training Estate, Caerwent, Monmouthshire, NP26 5XL, NGR: ST2920481020

On the 14th July 2016, I met with Julian Gregory of Ecovigour at the former Wormtech site to review current Crownhill Topsoils operations and future permitting requirements. During the visit I was taken to an area of the site which was being used as a waste transfer station. I found mixed waste, namely; household, commercial and industrial waste arising from the former RB Skip hire business stored on the site.

In light of the above, please note that Natural Resources Wales considers that there are reasonable grounds for suspecting you of committing offences contrary to breaching Regulation 38 (1) (a) in that you are operating a regulated facility without an environmental permit.

No further waste arising from the skip hire business is to be brought onto the Caerwent Army Training Estate until further notice. All waste stored must be removed and taken to a permitted waste transfer station.

Please can you contact me on the number below to discuss the points raised in the letter and to arrange a site meeting, I will be looking to conduct a full review of the Crownhill operations and further assess future permitting requirements at the Caerwent Training Estate.
