NRW met on the Malthouse Lane site with CAR owner Ronald Jones. In attendance was Richard Palmer (Lead Officer) and Jonathon Lee. The visit was pre-arranged and was instigated to undertake a Depollution Audit Checklist, designed to ensure that the depollution of vehicles is being carried out correctly by the operator, as stipulated in the permit and as required under the ELV Regulations 2003.

A1 Specified Activities - Action only - Permit Condition 1.2.2

During our inspection it was observed that the oil filters were not being removed. Your permit and the ELV regulations require that the oil filters are fully removed in order to consider a vehicle fully depolluted. The oil filters can either be drained/squeezed to clear all oil present at your site using the correct equipment or can be bulked up and sent onward for further treatment at another permitted facility. If you are selling the engines on as workable parts then you will need to evidence they are not waste through appropriate storage of the engines - for example, they must be stored inside and have appropriate labels to identify them as a non-waste part. If you cannot demonstrate this then the parts will be waste and therefore must be treated as such (i.e. be fully depolluted and be sent on to a permitted facility for recovery or disposal).

At this time we are issuing advice and guidance only, and giving you an action to rectify this breach. Please note, that should non-compliance continue then you may be breached in future.

Advice/Guidance was again recommended that the site was below the required upkeep standard and needs improved housekeeping and best practice on storage of waste oils. Also advised was the clearance of the inside area so depollution of ELV can take place in this area rather than outside as currently is taking place.
