I did note that de pollution was still be carried out on the impemeable surface outside the shed and I urge you to continue to prepare the shed in order that depollution can be done within the covered area.

There is a requirement for a board to be displayed at the entrance with the required information as set out in your permit, I have not breached you on this at this time as I am aware it was stolen. This notice must be replaced.

I have breached you on condition C1 under permit condition 2.3.1. This is in connection with there being no Technically Competent Manager trained as rquired by your permit.

You must arrange for training of one member of staff for this role.
